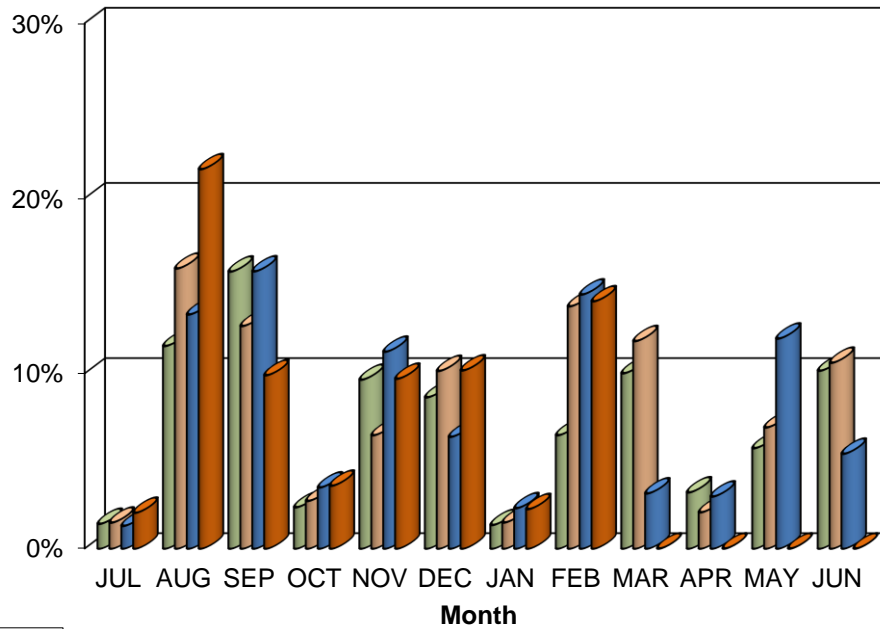

Rate Collections Analysis % Collected Each Month

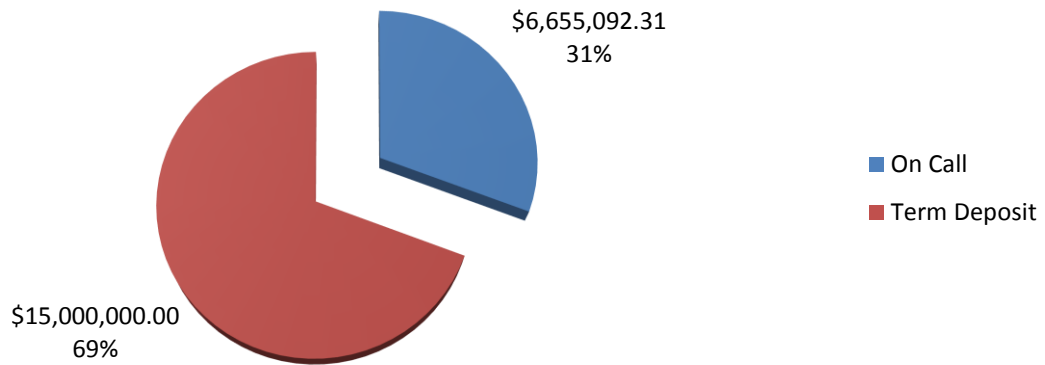
