

## **Kyogle Council**

### **Unconfirmed Minutes of the Ordinary Meeting held in the Council Chambers, Stratheden Street, Kyogle, on Monday, 10 November, 2014.**

## **ITEM 5 QUESTION TIME**

Elva Jones, of Kyogle, told the Council she was “deadset” against the amalgamation of Kyogle Council. She asked when more lights were going to be installed at the Kyogle Pool. Mrs Jones said an increased number of people had joined the swimming club this year and as a result, swimming club was going longer into the evening. She said the current lighting was not adequate and had been an ongoing problem for a number of years. She said the lack of adequate lighting had become a safety issue. Mrs Jones asked Council to look at the possibility of financing the installation of lights at the end of the pool.

The Executive Manager Urban and Assets Graham Kennett said there was no money in the budget currently for the installation of lights as requested by Mrs Jones. However he said Council still had the lights used to illuminate the pool that had been removed two years ago due to concerns over the structural integrity of the pole and mounts. Mr Kennett said Council would look at the feasibility of re-erecting those lights.

Councillor Ross Brown arrived at the meeting at 5.06pm.

Anne Reardon, of Kyogle, was concerned that the Listening Post tour, in particular the Listening Post held in conjunction with the Kyogle Farmers Market, had not been adequately publicised and asked if Council could hold a public meeting on the draft Long Term Financial Plan and the issue of amalgamation.

Mayor Danielle Mulholland said the Council would take the question on notice.

Fiona Borello, of Theresa Creek, who is a co-owner of land at Simpkins Creek which adjoins the site of a proposed Transgrid communications tower, asked why the two valuations obtained for the site by Transgrid and Council were so different. She had concerns that the tower's location would negatively impact a tourist trail and the valuation of her property. She asked if Council would compensate her for the devaluation of her property and what other crown property it intends to sell off?

The Executive Manager Infrastructure Works Jeff Breen said the vastly different valuations were the result of the independent valuers undertaking the valuations of two different bases.

Council's valuation was on an opportunity basis and Transgrid's was on a land value basis. After significant negotiations, a middle ground value was agreed on by Transgrid and Council. Mr Breen said Council was in the position that if did not agree to provide the easement to Transgrid, then Transgrid could seek to compulsory acquire the land. He advised that Council has sold easements and closed roads in the past and would in all likelihood continue to do so in the future.

The Executive Manager Planning and Environment Greg Meyers said the Transgrid tower could be erected without Council consent under the State Environmental Planning Policy Infrastructure. As a result, Council has no role in determining whether or not construction of the tower can proceed. He said if adjoining land owners wanted to pursue the approval of the tower they would need to go through the Land and Environment Court.

Councillor Chris Simpson asked if Council had considered leasing the land to Transgrid?

Executive Manager Infrastructure Works Jeff Breen advised the meeting that Council had looked at various options and had sought legal advice. Council's solicitors had advised it to create an easement and to seek a one-off compensation fee.

Jan Mills, of Tabulam, a co-owner of land at Simpkins Creek which adjoins the site of a proposed Transgrid communications, said the tower would have a significant negative impact on the value of the family property. She said there were numerous other sites on which the tower could be erected and which would not impact on neighbouring properties.
